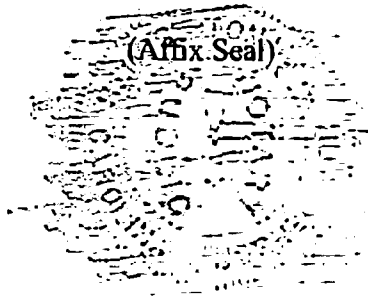
I, Karen Jane Baker (Affiant), state under oath that:
